**MEMBERSHIP INVESTMENT SCHEDULE**

Annual membership (12 months). For applications received between January 1 and June 30 of the same year, the membership investment schedule is figured on the basis of the annual gross sales volume for the preceding year, or a new store will use an estimated gross sales volume. The membership renewal date is the following January 1. The investment schedule is as follows:

\$100,000 and up	\$420.00
\$750,000 to \$100,000	\$396.00
\$300,000 to \$750,000	\$330.00
\$150,000 to \$300,000	\$270.00
Up to \$150,000	\$200.00
Branch Stores (each )	\$ 60.00

**Prorated investment (18 months)** For applications signed between July 1 and October 1, the membership investment is one and one-half times the annual rate and the renewal date is January 1 of the second year.

**Prorated investment (15 months)** For applications signed between October 1 and December 31, the membership investment is one and one-quarter times the annual rate and the renewal date is January 1 of the second year.

**Branch Membership:** The highest volume store is subject to the above schedule and each additional store will be at \$60.00 up to a maximum of \$900.00 for firms with 12 or more locations. Branch locations of member headquarters **shall be members** for the main firm to receive membership status. Branch stores are entitled to receive association services.
